# 1. City Profile

Tezpur is a town in Sonitpur district, Assam state, India. Tezpur is located on the banks of the river Brahmaputra, 175 kilometers (109 mi) northeast of Guwahati, and is the largest of the northbank cities. Tezpur was under the rule of the Koch dynasty in the 9th century, and later became apart of the Ahom kingdom in the 16th century. Modern Tezpur is a cultural and educational hub, home to a number of archaeological sites, temples, and monuments.

Tezpur Municipal Board is responsible for the Municipal Solid Waste Management of Tezpur within municipal area as per the Municipal Solid Waste Management Rules, 2016. Tezpur Municipal Board is determined to improve the process of Municipal Solid Waste (MSW) management in Tezpur at Morabharali, Balichapori in the State of Assam and in pursuit of the same has invited proposal for operation and maintenance of Integrated Municipal Solid Waste Management Facility (processing and disposal) and material recovery facility considering existing plant, machinery & fresh waste generation.

# 2. Details of Waste Processing Plant and Machinery located at Morabharali, Tezpur

At present Tezpur MB have Trommel Waste Composting Machine with trommel screen size of 30mm, 16mm & 4mm with processing capacity of 50TPD and 2(Two) nos. of Organic Waste Converter Machine with Capacity of 500kgs each per day located at Morabharali, Tezpur. The Trommel waste composting machine was handed to Tezpur MB in the year 2011 by the Air Force Tezpur, Sonitpur. The entire waste is collected by the Tezpur MB through hired NGOs/Pvt. Organizations etc. and taken to existing dumpsite located at coordinate 26°37′56.3″N, 92°48′53.1E, Morabharali, Tezpur.



## 3. Scope of Work

- Processing of fresh waste using existing Plant and Machinery at Municipal Solid Waste Management Plant located at Morabharali, Balichapori, Tezpur
- 2. Initial overhauling of the machinery & weighbridge, as required to make the plant fully operational, including supply of Consumables for overhauling.
- 3. Arrangements for Stamping and Certification of Weigh Bridge, excluding the Statutory Fee.
- 4. Providing Vehicles, Material Handling Equipments etc. required for operation of the plant, POL and Manpower for operation of the same, PPEs for Operators, repair & maintenance of such equipment and vehicles.
- 5. Providing all necessary manpower for the Plant Operation and Material Recovery Facility (MRF) operation. Welfare of the supplied manpower including providing PPEs, regular Health Check up etc.
- 6. Regular maintenance of Plant and Machineries including supply of consumables like Lub. oil, Electrical consumables and other miscellaneous consumables.
- 7. Ensure total stabilization of the waste dump, so that no offensive odors or leachates generates.
- 8. Handling, shifting, packaging, stacking the finished product of Municipal Solid Waste Management Plant at storage shed / warehouse, keeping those ready for disposal.
- Manual segregation of waste into paper, plastic, metals, hazardous waste substances etc. and maintenance of proper record in an MRF (Material Recovery Facility) center on daily basis.
- 10. Suitable packaging the recovered materials, provide manpower and materials for packaging the same and stacking the same at shed / warehouse for disposal.
- 11. Handling and due disposal of Hazardous waste, Sanitary Waste and C&D, if detected, as per guideline.
- 12. Regular Maintenance and upkeep of the Weigh Bridge.
- 13. Book Keeping and Maintenance of proper records of daily Plant operation and MRF including recording entry and exit of garbage Vans and submit copies of the same to the Tezpur MB authority at regular interval or on demand.
- 14. Ensure Compliance of Municipal Solid Waste Management Rules, 2016.

#### 4. Exclusions from the Scope:

- 1. Power Bills All existing liabilities and future liabilities to be generated from the Plant operation will be directly settled by the Municipal Board with APDCL.
- 2. Statutory Fee of Stamping and Certification of Weigh Bridge.
- 3. Any expenditure of Capital nature arising out of break-down of the Plant in Operation (For instance, Replacement of Electric Motor, Rubber Conveyor Belt etc.). Such expenditure will be borne by Tezpur Municipal Board.
- 4. Collection and Transportation of Municipal Waste from sources.
- 5. Disposal of Finished Product.
- 6. Disposal of Bio-Medical Waste.

The objective of the proposal process is to operate the existing Trommel Waste Composting machine and handling of fresh waste as per Solid Waste Management Rules, 2016 and Hon'ble NGT guidelines located at Morabharali, Tezpur, Sonitpur. The expected outcome is to address waste minimization, maximize resources recovery, and disposal of waste at zero waste concept. The resources recovery aspect outlines segregation, composting and recycling.
